Designate your planned gift today to help ensure the future of Rolling Hills

1. Name Rolling Hills Church as a beneficiary of your IRA, retirement plan or annuity.

Retirement funds are often our largest assets, but they can create tax problems for those who receive the funds after we've passed.

Designating a portion of your retirement funds to Rolling Hills is simple and will reduce or eliminate the tax burden for your retirement savings.

2. Name Rolling Hills Church as a beneficiary of your life insurance policy.

Adding Rolling Hills as a beneficiary of all, or a portion, of your proceeds can be a great way to create a lasting legacy after your lifetime. Your designation can be changed at any time and does not cost anything right now to do this.

3. Name Rolling Hills Church as a POD beneficiary on your certificate of deposit.

Many of us own bank deposits which we choose to "roll over" each year. Did you know that CDs make wonderful future gifts for your church? Simply have your bank name Rolling Hills as a "Payable on Death" (POD) beneficiary for a portion, or all, of the proceeds after your lifetime.

4. Create a simple amendment to your estate plan.

Making a gift through your estate plan does not mean you have to rewrite your entire plan. A short one-page codicil (will) or amendment (trust) to specify the gift that Rolling Hills will receive is usually all that's needed.
